

Saddlebrook Appaloosas Stallion Service Contract- Shipped Cooled and AI Semen

THIS AGREEMENT is made and entered into this day and month written below between SADDLEBROOK APPALOOSAS, OCONOMOWOC, WISCONSIN (“Stud Manager”) and _____ (“Mare Owner”)

The parties agree as follows:

- Mare Owner agrees to breed the mare (“Mare”)

to ZIP ME IMPRESSIVE (HYPP N/N) standing at SADDLEBROOK APPALOOSAS, OCONOMOWOC, WI for the _____ season and to pay the breeding fee together with other reimbursable expenses herein.

- The stallion service fee shall be \$1200, \$250 of which is payable at the date of execution of this contract as a Booking Fee. The Booking Fee serves as a non refundable deposit. The balance of \$950 will be paid prior to semen being sent. A copy of both sides of the mare’s registration papers must be included with this stallion service contract.
- Additional charges will be made for the deposit on the shipping container (\$250). The Equitainer deposit will be refunded to Mare Owner in full if Equitainer is returned to Stallion Owner within 72 hours of breeding date. **All standard shipping charges are included in the stud fee.**
- Mare Owner shall attempt with reasonable diligence to settle Mare; if however, for any reason the mare does not settle, mare owner will hold stallion owner and manager harmless. The breeding season for shipped semen begins February 5th and closes June 15th at which time all shipments will be discontinued. If Mare does not settle after three breeding shipments, owner has the option of waiting for the next year or bringing the Mare to the farm. **Semen is available every weekday with advance notice.** A \$200 collection fee will be charged each time the stallion is collected for your Mare and semen is shipped beyond the first two. **(The cost for the first Two Collections is included in the Stud Fee).** Stallion owner must be notified 24 hrs prior to the date semen is to be shipped, no later than 3:00pm cst.
- Stallion Owner guarantees live foal from the breeding contracted herein. Live foal is defined as a foal that stands and nurses without assistance. Should the Mare prove not to be in foal in the year bred or lose her foal, or should the foal not stand and nurse without assistance, Mare Owner shall notify Stallion Owner in writing within one week of the foaling date (or the date the Mare is proved not to be in foal or loses her foal); such notice shall be accompanied by a statement from a licensed veterinarian verifying that the foal is not “live” as defined above or has been lost as stated above. Under the foregoing circumstances and upon receipt of the specified notice, it is agreed;
 - Stallion owner shall give to Mare Owner a free season to the stallion the following year only and to the same Mare originally booked (unless otherwise mutually agreed in writing between Mare Owner and Stallion Owner). The Free season includes the stud fee and booking fee. Deposit on Equitainer, and subsequent additional collections charged as specified above. No other offers regarding prizes or awards shall apply to these foals born after 2009. See prize contract for more details. (attached)
 - If Mare Owner fails to deliver the Mare (or a substitute Mare if mutually agreed as stated above) for rebreeding the following year, then any and all fees paid shall not be refundable; the right to rebreed is thereby canceled and Stallion Owner is released from any further obligation whatsoever.
- This contract shall not be transferable by Mare Owner without the prior written consent of Stallion Owner. A breeders certificate will be issued when the Mare Owner notifies Saddlebrook Appaloosas of the foal and only after payment of all bills due on the Mare has been received. This agreement constitutes the entire agreement between the parties; any amendment to or modifications of the terms of this agreement must be in writing.
- Should it be necessary for Stallion Owner to employ an attorney to enforce any of the terms of this agreement, including collection of money owed, Mare Owner shall pay all reasonable attorneys’ fees, costs of suits, and other expenses reasonably related to enforcing this agreement.
